During the first four months of 2012, the Clark County Bar Association **Nuts and Bolts** program will present four lectures on **Basic Trial Skills** by local expert practitioners. The format will be the same – a two hour lecture at the Quay geared towards attorneys who are new to practice or who don't do a lot of litigation and might like to add it to their practice.
