



# PRESIDENT'S MESSAGE

# No Joking, Things are Serious


April 1st, traditionally known as "April Fool's Day" and the date for practical jokes, originates in the Nun's Priest's Tale from Chaucer's Canterbury Tales. On the thirty-second day after March, a sly fox tricks a rooster named Chauntecleer (of "cocka-doodle-do" fame), preying on the rooster's vanity. But fear not, in the tale the rooster escapes the fox by flattering the fox's vanity to distract him. Once bitten twice shy, the rooster does not fall for the fox's tricks again.

While I could make reference to lawyer vanity and lawyer tricks, this story really has nothing to do whatsoever with the state of the Bar. But it provides a humorous lead in to otherwise grim news.

When I was in Iceland last Summer, a popular t-shirt said (in Icelandic), "we have lots of ash, but no cash." At least they have ash. The CCBA doesn't even have that.

The state of the Bar is not well. At the current rate, the Bar will run out of money and shut its doors before the end of Summer. This sorry state results from a confluence of events: (1) declining CLE revenue as more attorneys do online webinars and the WSBA encroaches on our formerly monopolized CLE territory; (2) decreased profit margin on the newsletter due to increased printing costs (please go green!); (3) anomalous legal fees, not yet concluded, to terminate the health care plans

that were a stone around the Bar's neck. The chart below should adequately convey to our members the reality of our financial condition.



The Bar must change to survive. One thing we must all ask ourselves is, "What do we want our Bar to be?" Some young attorneys legitimately inquire, "Why would I wish to join the CCBA?" The Hearsay is great, but it is only 10 minutes of reading once a month. Why would someone wish to be part of the CCBA? To rate judicial candidates? To go to the Barrister Bash? To participate in the Southwest Washington Lawyer Referral Service? These legitimate questions need serious answers. So, Bar, speak out. We are all ears.

# **Mock Trial Results Are In!**



Thanks to the leadership of Judge Lewis, the hard work of the high school teams and coaches, and our outstanding judge and attorney volunteers, the 2011 Mock Trial program was very successful. A big thank you also goes to the Clark County Bar Association for providing food and drinks for the volunteers.

In the local competition, teams from Ridge-field, Fort Vancouver, Camas, Seton Catholic, Stevenson, Columbia (White Salmon), and Hudson's Bay competed against each other. In Division One, the top two teams were Ridge-field and Fort Vancouver. In Division Two, the top two teams were Camas and Hudson's Bay. The best witness award was a seven way tie among students from Ridgefield, Ft. Vancouver, Seton Catholic, Hudson's Bay, Columbia and Camas. The best attorney awards went to students from Ridgefield and Camas.

The top four local teams continued on to the state competition. The Washington State Mock Trial competition was held March 25th-27th at the Thurston County Courthouse in Olympia, Washington. At the state competi-





tion, out of 22 teams, Fort Vancouver placed 10th, Camas placed 11th, Ridgefield placed 12th, and Hudson's Bay placed 19th. Further, each school had students nominated for best attorney and best witness. According to Judge Lewis, our local teams were "Very competitive -- prepared, poised and professional against tough teams from all over the state."

The names of the local attorneys and judges who volunteered during Mock Trial as raters, coaches and judges are too numerous to list. The competition simply could not be held without the assistance of all of these volunteers. One of these individuals is Craig Schauermann. Craig has been coaching the Hudson's Bay team since 1999 and the team has also continued on to the state competition many times. Craig believes that the Mock Trial program is extremely beneficial for students, no matter what career or job they choose. Craig says, "The program teaches them to think independently and become better citizens." Craig also noted that competing at the state level allows students the opportunity to experience traveling to a different part of the state and stated that "for some students, these trips are the first time the student has ever stayed in a hotel. These types of experiences are very valuable for the development of young adults."

The Mock Trial committee thanks all of this year's volunteers. Please consider joining us again next year!

# It Started Here

HEARSAY invited candidates for the WSBA Board of Governors to submit brief articles in support of their candidacy

My initiation into the practice of law occurred in Clark County. I was a Rule 9 intern in the Prosecutor's Office. Jim Sellers was one of my supervising attorneys. I lived with my brother Ed Kelly and my sister-in-law Busse Nutley. Ed was a sole practitioner; Busse would go on to become a State Representative and Clark County Commissioner. The following year, Superior Court Judge Tom Lodge administered the oath of attorney to me in his courtroom.

Now, 35 years later, I am seeking to represent the lawyers of Clark County as a candidate for the 3rd Congressional District seat on the Board of Governors.

I am a principal with the Chehalis law firm of Hillier, Scheibmeir, Vey & Kelly, P.S. My practice focus is business, tax, real property, probate, and municipal law.

In 1988 I heard WSBA president Betty Braclin speak about the Bar's financial issues. She said the Board of Governors was considering whether or not to add a member at large, and perhaps a member who was a certified public accountant, to the Budget and Audit Committee. I was a CPA and volunteered. I was on that Committee from 1998 to 1994. Steve Tubbs, the WSBA Governor for the 3rd District, as WSBA Treasurer in 1993, chaired that Committee. Steve has endorsed me.

In the October 2010 Bar News, current WSBA President Tootle identified as "significant issues" matters related to the use of resources, court funding, and licensing fees (i.e., financial issues). "Whether to increase our members' licensing fees will be a huge issue for us. The BOG is cognizant of the difficult financial times all people face, including WSBA members. However, even in a difficult economy, WSBA's cost of doing business increases."

The Letters to the Bar News Editor indicate some dissatisfaction with use of Bar funds. I believe Bar funds should be used to assure the public that lawyers are competent, ethical, and profes-

sional. Bar funds should be used for member services and measures directly related to the practice of law, including Bar sections, committees, panels, and boards. Other uses of Bar funds should be securitized, minimized, and/or eliminated.

I, like many of you, have participated in various public service and bar association activities. Some of my service is listed in my WSBA Candidate Statement. I perceived a need related to WSBA financial issues/better use of resources and felt I could again contribute to a solution. I like the people I know on the BOG. I like lawyers as people, care about their families and their struggles with personal and professional demands. A Governor is expected to communicate with the members he or she represents about Board actions and issues, as well as convey member viewpoints to the Board. I am available and accessible. Your comments and concerns are always welcome.

On March 15 you should have received an e-mail from Elections Online. That e-mail contains voting instructions and a link to the ballot. If you did not receive that e-mail, a second message from Elections Online will be sent at the end of March.



# SUPERIOR COURT BENCH/BAR COMMITTEE **MEETING MINUTES**

**MARCH 8, 2011** 



**JOHN FAIRGRIEVE** CCBA Vice President

The meeting began shortly after noon. Persons present were Judge John Nichols, Judge Lewis, Ann Christian, Clark Fridley, Heather Beasley, Jolene Sell, Clay Spencer, Suzan Clark and John Fairgrieve.

### **OLD BUSINESS:**

- 1. Competency evaluations being conducted on out-of-custody criminal defendants by Western State Hospital (WSH): Ann Christian mentioned that there has been no improvement in the continuing problem with the time it takes to have out of custody criminal defendants evaluated for competency, diminished capacity or insanity and, if anything, the problem has gotten worse. Ann will continue to monitor the situation.
- 2. Newton pleas in criminal cases: John Fairgrieve explained to the committee that the Prosecuting Attorney's (PA's) office was reviewing its policy concerning Newton pleas and the language concerning Newton pleas contained in its current plea offer form. He stated that he hoped to be able to relay any changes to the current policy at the committee's next meeting.
- 3. PA's office policy concerning the use of the Residential Drug Offender Sentencing Alternative (Residential DOSA). John Fairgrieve explained that this issue was also currently being discussed in the PA's office and his hope was to have a clear policy position to outline for the committee at next month's meeting.

### **NEW BUSINESS**

1. Electronic discovery: John Fairgrieve described to the committee that the PA's office was exploring the possibility of moving to an electronic discovery process in criminal cases that would involve creating electronic files for discovery on a server in the prosecutor's office and giving criminal defense attorneys

access to the discovery files over the Internet. The proposal is in the early states of evaluation and many issues, not the least of which is start-up cost, need to be addressed prior to potential implementation.

- 2. Judge Lewis reported that the 2011 Mock Trial program was successful and that a number of teams advanced to the state finals. He thanked the large number of attorneys who donated their time to this year's program.
- 3. Ann Christian reported that the number of appointments of attorneys to probation violation cases for indigent criminal defendants was down for the first two months of this year as compared to the previous year.
- 4. Judge Lewis asked if the Prosecuting Attorney's (PA's) office had a policy concerning the number of charges that a deputy prosecuting attorney files in a case. In particular he asked if there was any value in filing multiple misdemeanor or gross misdemeanor counts in a case involving felony counts where the additional misdemeanor or gross misdemeanor counts did not change the defendant's standard sentencing range or post release supervision. John Fairgrieve stated that he would discuss this issue within the PA's office and report back to the committee.
- 3. Next Bench Bar committee meeting: The committee will meet next on Tuesday, April 12, 2011 at noon in Judge Nichols' jury room.

# **CCBA** seeks input on Condemnation CLE

The CLE Committee of the Clark County Bar Association is trying to gauge what kind of interest there might be in a CLE on condemnation. Government authorities frequently approach prospective clients about the purchase of property rights for right-of-way acquisitions for road widenings or utility easements under the at-least implied threat of condemnation. However, very few condemnation actions are actually filed to acquire these rights; the transfer of property rights to state the local government is overwhelmingly voluntary.

As a result there is very little opportunity for most practitioners to gain the experience of litigating these cases that is helpful in evaluating and advising clients regarding proposed property acquisitions by the government. The purpose of a seminar on condemnation would be to cover how condemnation actions are actually litigated and the rights of that prospective condemnees have in order to assist attorneys in evaluating cases and advising clients.





# **GETTING TO KNOW: SCOTT STAPLES**

"Getting to Know" is a monthly feature designed to better acquaint the membership with our local attorneys, judges and other people of interest to the Clark County bench and bar. This month's subject is Scott Staples, a partner with Schauermann Thayer Jacobs & Staples in Vancouver.



### Where did you grow up and how did you end up in Vancouver?

Born and raised in Vancouver.

### What or who inspired you to practice law?


### Let your mother know how much she means to you, in the form of a Haiku.

Statistics for February include 77 clients seen in advice clinics, 20 in Family Law, 14 in Family Law paperwork review clinic, 7 in the Bankruptcy clinic, 4 in the General Law clinic and 270 in Housing Justice Project clinic. We placed 4 cases with an attorney for direct representation. There were 82 hours of volunteer attorney time donated.

The VLP exists because of you, the attorneys who volunteer your time so generously. We could not serve the clients we do without you. But, there is another side to our operations and that is financial. We need to pay our staff, pay rent, telephone, interpreters, insurance and the other expenses of running an office. Our funding comes from two main sources. The Legal Foundation of Washington who administer the Interest on Legal Trust Account (IOLTA) money and from Clark County Department of Community Services. Due to the economic times both our funding sources have reduced our grants the past couple of years. In 2007 the IOLTA fund was at 9 million dollars. This year it is 1.5 million. This money supports 22 legal aid programs throughout the state.

The VLP has cut our budget everywhere we can. We are not printing our annual report, we are not providing packets of information for our clients, our janitorial service agreed to reduce our fee, we lost a half time position. We are doing everything we can to reduce costs and not reduce services to clients.

We need your help! Yes, I am asking for money (even if you volunteer). Can you send one hour of billable time to the Campaign for Equal Justice (www.c4ej.org)? They do our fundraising and what you donate will come back to us. We are going to do a telethon in May. So, if you donate before then you will not get a phone call. Otherwise, be warned. We are going to call and ask for your help. I know you all know how important the work we do is and how it impacts the lives of our clients. Please be as generous as you can.


